Groom Law Group is once again hosting its 3rd annual 1L Summer Mentorship Program for rising 2L law students who are working in DC this summer.

We also will hold the following four dinner programs (at our offices at 1701 Pennsylvania Avenue NW) geared toward embarking on a legal career in DC (*dates subject to final confirmation):

- **Wednesday, June 5 (6 pm) – Meet Your Mentor & Law Firm 101**
How are firms structured? How do you make partner? How are assignments made? We'll answer your questions about how law firms really work.
- **Wednesday, June 26 (6 pm) – Outside the Law Firm Box**
There are a myriad of legal career options in DC - from Capitol Hill to federal agencies to in-house counsel. Hear from lawyers with wide-ranging experiences about the paths they have taken to discover which type of practice may be right for you.
- **Monday, July 8 (6 pm) – Nuts & Bolts of Law Firm Interviewing**
From Vault research to on-campus interviews to call-backs, we'll give you the scoop - plus voluntary mock interviews to get extra practice.
- **Wednesday, July 24 (6 pm) – Networking Dinner**
Developing contacts is a key to success at all stages of a legal career. We'll end our summer with an evening out that includes tips for networking and staying in touch.

Note that participation in the Summer Mentorship Program is voluntary and not an offer of employment. There is no obligation on Groom or Program participants regarding future participation or employment.
